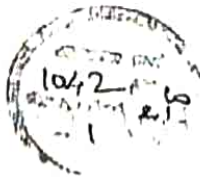

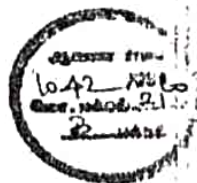

AND WHEREAS It is considered necessary and expedient that the object of the Trust should be reduced to writing.

NOW THIS DEED WITNESSES AS FOLLOWS:

1. It is hereby declared that the Trustees hereinafter shall stand passed upon the Trust for the object set out hereunder a sum of Rs. 1001/- (One thousand one only) given by the Author and Founder, the receipt of which sum the Trustees admit and acknowledge, and all other property that may from time to time be bequeathed, devised, donated, gifted, or otherwise assured such manner of the Trust hereof, the property from time to time representing the same and the income thereof and the money rising there from subject to the powers and provisions details hereunder.

The Trust shall be called JEPPIAAR REMIBAI EDUCATIONAL TRUST and shall be constituted for the purpose, aims and objects hereinafter mentioned. The office of the trust shall be at Jepplaar Nagar, Kunnam Village, Sriperumbudur Taluk, Kanchipuram District - 631 604. In rental basis.

1. THE OBJECTS OF THE TRUST SHALL BE THE FOLLOWING:

- a) To establish, maintain, acquire, run, improve and develop educational institutions like Schools, Colleges, Poly Techniques, Medical, Dental, Engineering colleges, Business schools, Management and Computer Education Private Universities declared under Section 13 of the U.G.C. Act including hostels and also any other institutions without any motive of profit:

- b) To seek and get affiliation of the various institutions run by the trust and private universities to be formed in due course under Section 3 of the U.G.C. act to be formed in the due course to various universities of different disciplines.
- c) To seek and get approvals from the Government bodies such as, AICTE, MEDICAL COUNCIL, Dental Council, U.G.C., NCTE and Affiliation from the respective OTHER STATUTORY Universities affiliating technical courses as well as general academic courses and any other authorities at present in existence or to be established by the State Union Government from time to time.
- d) To award scholarship, prizes, etc, for the poor and deserving meritorious students.
- e) To establish, maintain, run, improve and develop libraries, reading rooms, and other facilities for the benefit of the students.
- f) To publish books, periodicals and other works without any motive for profit relating to Educational activities.
- g) To give donation and to takeover maintain, run and improve the educational institution / institutions having similar objects.
- h) To accept donations, gifts, presents, aid, grants, in cash or kind and movable or immovable properties, from the public, State Union Governments either as corpus or as in cash according to the directions of the donors for the purpose of carrying out the objects of the trust.

- i) To do all such lawful acts that may be necessary or incidental and conducive to the attainment of the above objects or any one of them.
- ii) To undertake such other activities as may be necessary for the promotion of the objectives of the trust.
- k) To give assistance to senior citizens / poor, deserving needy people by way of cash or kind.

2. BOARD OF TRUSTEES:

1. THE FIRST BOARD OF TRUSTEES shall consist of the following persons:-

- 1) Mr. N. MARIE WILSON, Son of Mr. Nestore, Christian, aged about 30 years, residing at Jeppidar Nagar, Kunnam Village, Sriperumbudur Taluk, Kanchipuram District - 631 604.
- 2) Dr. JEPPIAAR, Son of Late Mr. Jesu Adima, Christian, aged about 71 years, residing at No: 29, Ganapathy Street, Royapettah, Chennai -14.
- 3) Mrs. REMIBAI JEPPIAAR, W/o. Dr. Jeppiaar, Christian, aged about 66 years, residing at No: 29, Ganapathy Street, Royapettah, Chennai -14

Mr. Marie Wilson shall be the first Managing trustee of the trust and shall hold the office of the Managing Trustee of this trust for his life or until he resigns.

II) The aforesaid Managing Trustee at any time and from time to time, may fix or vary the number of trustees, appoint new or additional trustees. The Managing Trustee has full power to appoint any person from among their family members as trustee of this trust but such person shall belong to the Christian community.

III) ~~The founder hereby affirms that the first trustees of the Trust shall~~ be the three persons here in above referred to as the trustees including the founder.

IV) All the trustees who are, for the time being, and from time to time in office shall be referred to collectively as Board of Trustees.

V) Mr. N. Marie Wilson, shall hold office of this trust for his life time or until he resigns.

VI) The strength of the Trustees at any point of time shall not be less than two and more than six.

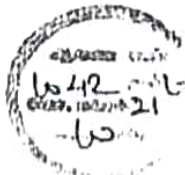
VII) A Trustee shall cease to be a Trustee if a resolution to this effect is passed by a majority of Trustees at a meeting.

VIII) It shall be open to anyone of the Trustees to retire from the office of the Trustees by giving one month notice to the trustees of their intention to retire.

3. PROCEEDINGS OF THE TRUST.

3. The managing Trustee of the Trust shall preside over all the meetings of the trust during the term of his office and if he is unable to attend the meeting, the Managing Trustee shall appoint one among the others as chairman of the meeting.
4. A resolution in writing signed by a majority of the Trustees shall be valid and effectual as if it had been passed at the meeting of the trustees duly called and constituted.
5. The quorum of holding the trustees meeting shall be two out of which one should be the Managing Trustee. In case of the Managing Trustee shall have a casting vote.
6. The decision of the majority of the Trustees shall be considered valid and must also be carried out accordingly.

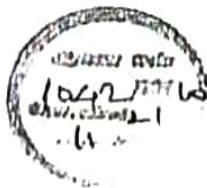
4. POWERS AND DUTIES OF THE MANAGING TRUSTEE

The Managing Trustee is empowered to do all such other things as may be necessary, incidental, conducive or convenient to the attainment of the objectives of the trust or any of them.

Without prejudice to the generality of foregoing, the Managing Trustee shall have the following powers.

To delegate any power as he can lawfully delegate to any person and to execute such power of attorney as they may think fit for the purpose.

1. To appoint any employee of his choice and to withdraw any power or revoke any appointment of any employee or attorney.
2. To buy or take on lease or exchange or gift/any immovable property for the Trust and to put up buildings or structures on the said property or under the control and possession of the Trust.

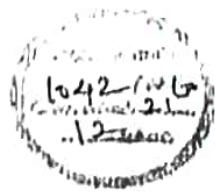

3. In the professed execution of the trust and powers hereto no Trustee shall be liable for any loss to the Trust properties arising by reason of any investments made in good faith except willful or deliberate fraud or wrong-doing on the part of the Trustee who may be made liable.
4. Except as otherwise, provided herein, none of the Trustees, for the time being, of the Trust shall have power jointly or severally to mortgage or charge or alienate any of the Trust properties.
5. To sell, give on lease or license, mortgage, charge, surrender, pledge, hypothecate, transfer, deal with or dispose of all or any properties, funds, or assets of the Trust, movable or immovable and to reinvest the proceeds in such other form of investment as would, in the opinion of the Managing Trustee be beneficial to the Trust.
6. To sub lease or let out any portion of the Immovable property in possession or under the control of the Trust at such rent and for such periods and on such terms and condition as they may think fit and to apply the income derived therefrom for the objects of the Trust.
7. To open, maintain, or operate bank accounts in the name of the Trust and such bank account may be operated only by the Managing Trustee.

8. To invest and deal with the funds of the Trust in such manner as may, from time to time, be deemed as expedient in accordance with the provisions of the Income Tax act, 1961 and, the Indian Trust Act, 1882 as amended from time to time and the Rules framed there under, as may be in force from time to time and to redeem, reinvest and vary such investments from time to time as may be deemed fit. Without prejudice to the generality of the foregoing, to invest in RBI Bonds, Post Office Savings Certificates and mutual funds as may be approved under the Income Tax Act 1961 and the Indian Trust Act, 1882 and redeem reinvest or vary the same.
9. The Managing Trustee shall have every power for the purpose of managing, conducting and administering the affairs of the educational institutions, hostels, medical institutions, universities and other establishments conducted by the Trust.
10. The Managing Trustee shall arrange for the maintenance of correct and proper accounts of the receipts and disbursements and of the liabilities incurred and of the assets acquired and for an audit every year of the accounts of the Trust and of the income and expenditure relating thereto and for this purpose the Managing Trustee shall appoint in consultation with the Board, an independent auditor or auditors.
11. The Managing Trustee shall have power to purchase, from time to time, such materials and things as may be necessary for the said educational institutions, universities and other establishments.

12. The Managing Trustee may, if and when he/she desires, delegate for a temporary period his/her authority in respect of the administration of the institutions to one of the trustees.

13. The Managing Trustee shall be the executive officer of the Board and as such he/she shall have power and authority for and on behalf of the Board.

- a) To carry out the resolutions of the Board.
- b) To sign papers, receipts and documents.
- c) To pay money due by the Trust and demand and get receipts therefore.
- d) To demand and receive money due to the Trust and issue receipts for the money so received.
- e) To open current and deposit accounts in the name of the trust with such bank or banks as the Board may from time to time authorize in this behalf to deposit the funds of the trust in such accounts on behalf of the trust.
- f) To borrow money from any trustee including bond/s, financial institution/s, Private financier or any one and execute any loan documents on this regard and offer Trust properties as security to them. In this regard Managing Trustee can execute and register mortgage deed or any deed or deeds, as may be demanded by the lender.
- g) To execute guarantee deed/deeds on behalf of the trust and offer Trust property as security.

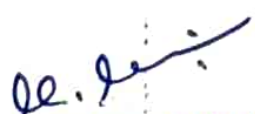


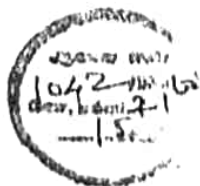

- h) To make, draw, endorse, accept, sign, negotiate or transfer, cheques, hundies, bills of exchange, bills of lading, railway receipts, warrants and other negotiable or transferable instruments, Government Securities or other securities.
 - i) To lease out for a period not exceeding three years at a time, lands and properties of the Trust which are ordinarily leased out:
 - j) To initiate, prosecute, defend compromise or refer to arbitration or abandon any legal proceedings or disputes and to sign all papers in connection therewith including vakkalath, pleadings, statements, affidavits, counter affidavits, Petitions etc., of any nature.
 - k) To appoint, employ, remunerate, remove, suspend, discharge, dismiss, re-employ, replace, transfer and accept resignation of staff and workers permanently, temporarily or otherwise:
 - l) To call for the meeting or meetings of the Board and
 - m) To execute all documents on behalf of the Board.
14. No act of the Managing Trustee requiring the previous sanction of the Board shall be invalid merely by reason of the absence of such previous sanction, if the said act should subsequently be ratified by the Board.
15. The Managing Trustee and other Trustees may reimburse themselves or may reimburse out of the Trust money in their hands all expenses properly incurred by them in or about the execution of the objects of the Trust and in discharge of their duties imposed on them under this Trust.

16. There shall be an annual meeting of the Board not later than 31st December when the annual audited statements of accounts shall be considered and adopted. The Managing Trustee shall, at such meeting, place before the Board a report of the working of the several institutions operated and

maintained by the Trust. The Managing Trustee shall give at least 14 days written notice of the meeting to the Trustees specifying the day, date, place time and agenda of the meeting. Along with the notice the Managing Trustee shall also send to every one of the Trustees a copy of the audited statements of accounts intended to be placed before the meeting.

17. The Board shall consider at the said meeting the report of the Managing Trustee and that of the auditor and the audited accounts and if the Board proceeds to approve and adopt them, such approval and adoption shall be by means of a resolution to that effect. The Board shall also transact such other business at that meeting about which due notice had been given as aforesaid. All the resolutions passed by the Board shall be recorded in a separate book. In the absence of the Managing Trustee anyone of the Trustees may be nominated by the Managing Trustee to preside over the Meeting.

18. Any Two Trustees - Including the Managing Trustee, of the Trust, may call a meeting of the Board, for the consideration of any specific subject or subjudice to be mentioned by the Trustees convening the meeting of the Board. There will be a notice of at least 14 days for every meeting so convened; the

posting of a prepaid letter to the proper last known address of a trustee and containing date, day, time, place and the agenda of the meeting shall be deemed to be a proper notice of the meeting and such notice shall be deemed to have been served on the day on which the letter so posted should normally reach the address in the usual course of the post. A notice may also be served on a trustee in person.

19. The business of the Board shall be transacted either at the meetings of the Board or by resolutions passed in circulation. The resolutions to be passed in circulation shall be sent to all the Trustees and the resolutions so circulated shall be deemed to have been passed only when a majority of the Trustees as per the quorum signify their consent in writing.
20. In all matters pertaining to the Trust, the decision of the majority of the Trustees as per the quorum present at a meeting if the Board shall be the decision of the Board and shall be binding on all the Trustees of the Board.
21. In the event of the votes being equally divided, the Managing Trustee shall have a casting vote in addition to his/her vote as a Trustee of the Board.
22. No act or resolution of the Board shall be invalid merely by reason of there being one or more vacancies on the Board. But, no act or resolution of the Board other than, act or resolution appointing or electing a Trustee shall be valid if the strength of the Board at anytime is less than two.
